All completed trophies not picked up after 90 days are subject to placement with a collection agency for payment and may be subject to collection or court fees to be paid by the customer. Prices shown on price list are based on standard form positions and sizes available. It does not include custom designs, form alterations, bases or habitat. These prices are figured by time and material. The following are not included in the mount price: repairing unnecessary holes/cuts, repairing broken antlers or horns, removing velvet, staining antlers, crating, boxing or packing for shipment. Artworks Taxidermy and/ or Danny Knight are not responsible for the condition of skin or trophy prior to receiving it for tanning or mounting. Many factors have a definite effect on the final result of the mount such as primeness, time of year, climate, and care of the skin or trophy in the field. All tanning is accepted at the customer's risk only. Please do not call inquiring when your trophy will be completed. We will notify you by mail or e-mail when work on your trophy has begun and again upon completion.
